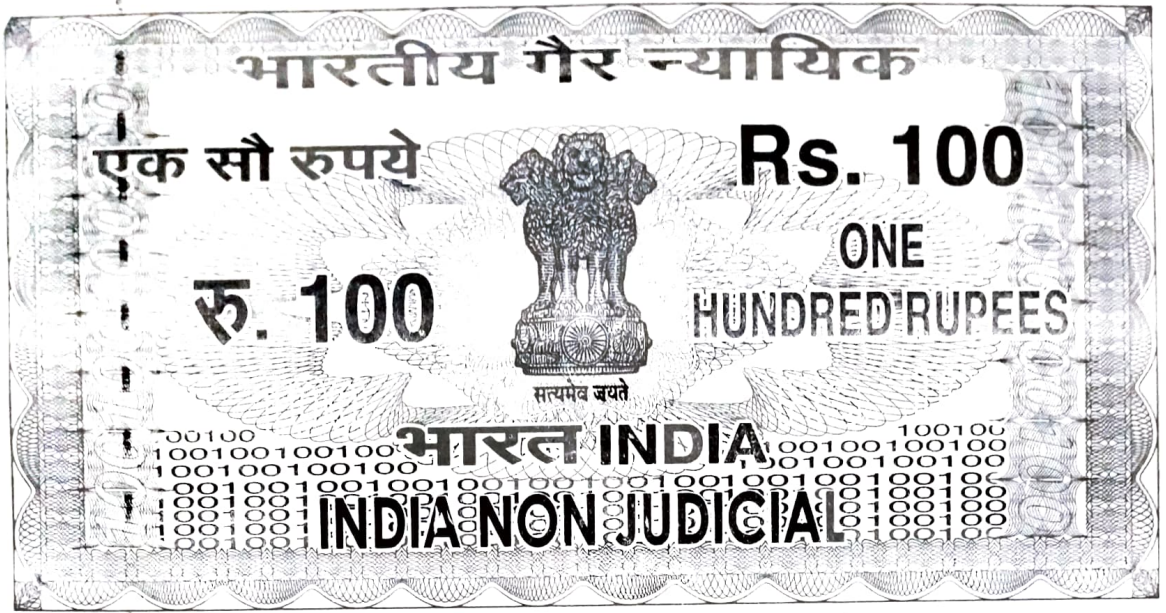

1. Student Training will be selected by mutual agreement between the home institution and the host institution.

Each institution shall appoint one member of its team to coordinate the programme on its behalf. Further, a coordination committee, consisting of

2. **Founder / Head Master / Head Mistress Government High School, Chinnalapatti-624301** or his /her nominee

Programme coordinator from the side of **G.T.N Arts College (Autonomous),PG Department of English, Dindigul-5** and Programme coordinator from the side of **Government High School, Chinnalapatti-624301 Dindigul District, Tamil Nadu** will periodically review and identify ways to strengthen cooperation between the two institutions.

CLAUSE 3

INTELLECTUAL PROPERTY

G.T.N Arts College (Autonomous), PG Department of English, Dindigul-5 and Government High School, Chinnalapatti-624301, Dindigul District, Tamil Nadu agrees to respect each other's rights to intellectual property. Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, copy rights and texts) of the other party.

CLAUSE 4

TENURE, TERMINATION AND VALIDITY

This MoU will take effect from the date it is signed by representatives of the two institutions, it will remain valid for **FIVE** Academic years from **2021- 2022 to 2025- 2026** and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither the PG Department of English, nor the **Government High School, Chinnalapatti-624301 Dindigul District, Tamil Nadu** will be responsible for any losses, financial or otherwise, which the other institution may suffer. However, **G.T.N Arts college (Autonomous), PG Department of English, Dindigul-5** and **Government High School, Chinnalapatti-624301** will ensure that all activities in progress are allowed to complete successfully.
