NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

#### **CLAUSE 1**

#### **CO-OPERATION**

Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies recognize their strengths in research and education in one or more disciplines of science engineering, management and social sciences, and their mutual interest in engaging themselves in academic cooperation.

### **CLAUSE 2**

## **OBJECTIVES/ SCOPE**

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies agrees:

- 1. To exchange information on research and educational programmes in the field of Computer Science.
- 2. To exchange information on teaching, learning material and other literature relevant to their educational and research program related to Computer Science.
- 3. To jointly organize short-term continuing education programmes on topics of mutual interest in the field of Computer Science and to invite each other's member of the team to participate therein.
- 4. To jointly organize seminars, conferences, FDPs, Guest Lectures and hands-on training on topics of Computer Science and to invite each other's team members to participate therein.
- 5. To jointly propose and engage in research or training program sponsored by funding agencies, and to invite each other's members to participate therein.
- 6. To exchange, on a reciprocal basis, members of the team levels for limited periods of time for the purpose of education and/or research in the field of Computer Science.

Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. # A. Joint Sponsored Research, Development and Consulting

#### **B. Student Exchange**

**Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5** and **Wagule Technologies** agree that Department of Computer Applications student exchange will be only for the sole purpose of educational/ research purposes like internships, projects, assignments, conferences and workshops and will be guided by principles listed below.

A home institution refers to the institution where a student is a full-time student or part time\* attached to the same, and from where he/she is expected to gain some knowledge certificates or degrees. A host institution refers to an institution that receives a student for a brief period of time to undertake a predetermined programme study or research/education programme.

- 1. Exchange students will be selected by mutual agreement between the home institution and the host institution.
- 2. His/her program of study at the host institution will be determined by mutual consultation between his/her academic adviser at the home institution and his/her "interim" academic advisor identified by the host institution.
- The host institution will evaluate an exchange student's performance in each course or module; award a letter of appreciation/completion.
- 4. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- 5. The exchange students will be liable to pay any type of fees for if any, for that particular program.

## C. Exchange of Scientific and Technical Material

Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies will exchange information on research and educational programmes and teaching/learning material related to Computer Science and other literature relevant to their educational and research programmes. Further, Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies agree to explore ways to share teaching/learning material, and other relevant literature, while respecting each other's intellectual property and other rights.

## D. Joint Conferences, workshops, FEPs, Guest lectures, and short-term courses

Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies agree to help identify and invite members from various areas of Computer Science from other institutions to participate in conferences, workshops and short-term courses. The terms and conditions for such will be worked out by mutual agreement between Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies.

#### E. Coordination

#### **CLAUSE 3**

# INTELLECTUAL PROPERTY

Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies agree to respect each other's rights to intellectual property.

Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

### **CLAUSE 4**

# TENURE, TERMINATION AND VALIDITY

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for FIVE Academic Years from 2020- 2021 to 2024- 2025, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 nor Wagule Technologies will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, Department of BCA, G.T.N Arts College (Autonomous), Dindigul-5 and Wagule Technologies will ensure that all activities in progress are allowed to complete successfully.

Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party. There is no any financial commitment on behalf of both the parties for signing this MoU/approval of this MoUs.
